# NTERNATIONAI

### ADVOCATING FOR ISRAEL ON THE GLOBAL STAGE

- ► United Nations Engagement: Presented forensic evidence of Hamas' atrocities to senior UN official Pramila Patten, confirming patterns of sexual violence during the October 7th massacre. This evidence was crucial in gaining international recognition of the sex crimes committed.
- ➤ **Survivor Testimony:** Organized live testimony at the Human Rights Council from Yuval Raphael, a survivor of the Nova Music Festival, in front of diplomats from 100+ countries. Her story highlighted the human toll of terrorism and the strength of the survivors.
- ► International Criminal Court: Submitted an amicus brief emphasizing the Israeli justice system's capacity to hold its officials accountable, challenging the ICC's jurisdiction over Israel.
- ▶ **Private Screening:** Held a screening for 84 global leaders, featuring uncensored footage of the October 7th massacre, exposing the horrors endured by victims and countering denialist narratives.



#### STORIES THAT INSPIRE ACTION

Yuval went to the Nova Festival to dance with friends. At dawn, Hamas invaded. She sought refuge in a roadside bomb shelter, where terrorists attacked with bullets and grenades. Only 11 of 50 people in the bomb shelter survived. Yuval's survival is a testament to human resilience. Her story, shared internationally, continues to inspire global action.





### PROVIDING JUSTICE FOR THE VULNERABLE

JIJ's Free Legal Aid Department ensures access to justice for survivors of terrorism, human trafficking, and discrimination. In 2024, JIJ expanded its services to support war survivors and individuals with disabilities.

- ► Cases Handled: Provided free legal aid to 2,733 individuals, including:
  - ► 17 survivors of the October 7th massacre
  - ► 68 families seeking citizenship or residency
  - ► 40 survivors of human trafficking
  - ▶ 32 wounded Israeli soldiers
  - ► 112 refugees from Ukraine, Russia, and Eritrea

#### TRANSFORMATIVE STORIES

- ▶ **Nora's Fight for Citizenship:** Nora faced rejection in her Aliyah process after serving in the IDF. With JIJ's help, she reopened her case and is now closer to making Aliyah.
- ➤ Jamila's Struggle for Equality: An Eritrean refugee and mother of three, Jamila was excluded from housing aid during the war. JIJ fought for her rights, securing equal assistance for asylum-seekers.

JIJ's work ensured that she was not overlooked during national crises. Legal victories like Jamila's case have set precedents to protect other vulnerable groups.

FREE LEGAL AID

#### **COMBATTING HUMAN TRAFFICKING**

Project NOA is dedicated to fighting human trafficking and supporting survivors. In 2024, JIJ achieved significant milestones in this fight:

- ► Helped Israeli police dismantle a major trafficking ring, leading to the arrest of **14 traffickers**. This victory was made possible by the courageous testimony of a JIJ client from S. America, who was forced into labor under false pretenses.
- ► We met with First Lady Michal Herzog to discuss Israel's innovative anti-trafficking law.
- ▶ In 2018, JIJ persuaded the Knesset to adopt a **5-year pilot program** that treats women and girls in the sex industry as victims of abuse, and pimps as criminals. In 2025, we are working to make this pilot program permanent.
- ► Provided free legal aid to **40 survivors** of human trafficking, helping them rebuild their lives with dignity.
- ▶ In 2025, we're fighting to make the law permanent, ensuring prostituted women are treated as victims, not criminals.

#### A STORY OF COURAGE

Sofia was lured to Israel with fake documents and forced to work 15-hour days without pay. Her brave testimony led to the arrest of her captors, a pivotal moment in the fight against trafficking.



# ADVANCING HUMAN RIGHTS THROUGH LEGAL ACTION PROTECTING COMMUNITIES



Christian students in Israel's publicly funded Arab schools face discrimination as their curriculum prioritizes Muslim history, and excludes 2000 years of Christian history in Israel. We are committed to supporting the Arabic-speaking Christians who join the IDF, defend the Jewish State, and seek to integrate into mainstream Israeli society.

In 2024, JIJ filed formal petitions with the Ministry of Education to uphold the rights of this small community of allies to the Jewish people. This new partnership is built on a shared commitment to religious freedom and cultural preservation.

#### **UPLIFTING NEW IMMIGRANTS**

With antisemitism on the rise, JIJ assisted **170 new immigrant families**, and foreign spouses in securing residency and rebuilding their lives in Israel.

#### COMMUNITY EMPOWERMENT

JIJ supported 80 houses of prayer and non-profits, defending them against discrimination and securing their rights to operate freely. These efforts empower local organizations to serve their communities effectively.

## NTERNSHIPS

### EMPOWERING THE NEXT GENERATION

Education is a cornerstone of JIJ's mission. In 2024, we trained and inspired students and leaders through diverse programs:

- Hosted 23 Jewish university student leaders from 16 countries in partnership with the World Union of Jewish Students. These sessions focused on combatting antisemitism and countering pro-terror agendas on campuses.
- Organized 4 webinars, attended by hundreds of participants, covering topics like international law, human rights, and Israel's global standing.
- ► In the last 20 years, JIJ hosted internships and fellowships in Jerusalem, for over 400 students from 20+ countries, equipping them with tools to advocate for justice. Including 10 in 2024.

#### **IMPACTFUL MOMENTS**

Through JIJ's training, Sarah, a student leader from Canada, gained the confidence to confront antisemitic incidents on her campus.






#### **STANDING WITH SURVIVORS**

## WOUNDED SOLDIERS AND VICTIMS OF TERROR

In 2024, JIJ provided legal advocacy for **32 wounded soldiers** and their families.

➤ Yoni's Story: While protecting his country, Yoni was hit by shrapnel, causing a brain hemorrhage, a fractured skull, and damage to his eyesight. His hand was almost completely torn off, and only saved in a complex surgical operation. JIJ is helping him tackle the administrative and bureaucratic hurdles that stand between this wounded hero and a future filled with dignity.





During the escalation in Gaza and Lebanon, JIJ assisted **120 Israeli families** displaced from their homes. We provided free legal aid to help these families access secure housing and social security benefits.

▶ Rachel's Fight: Displaced from the Gaza border, Rachel and her four children struggled to access government resources. JIJ stepped in, ensuring her family received emergency support and financial aid to rebuild their lives.

### AMPLIFYING VOICES ON THE GLOBAL STAGE

#### DIPLOMATIC ENGAGEMENTS

In 2024, JIJ engaged directly with diplomats and policymakers worldwide to advocate for justice and combat antisemitism. Highlights include:

- ▶ Organized a side event at the United Nations session of the Human Rights Council featuring Professor Robbie Sable, Dr. Sigall Horovitz, and Nova festival survivor, Yuval Raphael. The event was attended by representatives from 18 countries, where they heard firsthand accounts of October 7th atrocities and were presented with JIJ's legal report From Intent to Action: Legal Perspectives on Hamas' Genocide.
- We delivered JIJ's report Echoes of Denial to the United Nations, detailing the rise of atrocity denial and its links to global antisemitism.

- Partnered with key decision-makers to enact policies that restrict funding to entities supporting extremism, including a one-year suspension of U.S. funding to UNRWA.
- Gave the floor to families of hostages to address the General Assembly of the United Nations.
- Partnered with 50 international organizations to demand that the International Committee of the Red Cross and UN bodies act on behalf of the October 7th hostages and victims.
- Our lawyers gave 23 media interviews, appearing on: <u>Kan en Español</u>, <u>i24News</u>, <u>Fox News</u>, <u>Honest</u>
   <u>Reporting</u>, and <u>The Jerusalem Post</u>.







#### STRATEGIC LEGAL ADVOCACY

JIJ's legal team prepared and submitted **amicus briefs** to international courts in 2024, defending Israel's sovereignty and human rights record. Key actions include:

- ► Challenging the **International Criminal Court's jurisdiction** over Israeli officials.
- ▶ Providing evidence of war crimes committed by Hamas, reinforcing Israel's right to self-defense under international law.

Started the Survivors Seeking Justice Project, a crucial campaign to preserve their testimonies and shatter denial with the truth. Taking their battle directly to international courts and global agencies.

► Mazal's Video Testimony: As part of the Survivors Seeking Justice project, Mazal shared her harrowing experience of survival, creating ripples of awareness and empathy globally.

#### A DOCUMENTARY THAT DEMANDS ACTION

JIJ proudly presents *SATURDAY October* 7, a compelling one-hour documentary featuring the stories of seven survivors of the October 7th massacre. This crowdfunded project confronts atrocity denial and rising antisemitism.

Through eyewitness testimonies, personal video footage, and accounts of resilience and heroism, *SATURDAY October 7* documents Israel's darkest day. The film is not just a documentary—it's a movement for truth, justice, and remembrance.


