THE HIDDEN HARMS OF PROSTITUTION: UNDERSTANDING THE EXPLOITATION BEHIND THE INDUSTRY

Prostitution, described as "the world's oldest profession," is more accurately understood as a structurally exploitative 'industry' that extracts profits from the bodies of vulnerable people through manipulation, humiliation, addiction, and physical abuse. Attempts to regulate this industry do not generate human dignity. The transactional and inherently violent nature of prostitution prevents a balanced power dynamic between the buyer and the person being prostituted, leading to dangerous, often deadly conditions.

The **Equality/Abolitionist/Nordic Model** aims to decriminalize & rehabilitate those who sell sex (individuals involved in prostitution) while penalizing the purchasers of sex, or "johns." The model also criminalizes third parties who profit from prostitution, such as pimps and traffickers.
